**NOTE:** SPOT round of counselling will be conducted on 4<sup>th</sup> December 2020 only for admissions in M.Tech course in following three programs against the vacant seats.

- 1. Computer Science & Engineering**
- 2. Nanotechnology**
- 3. Energy Science & Technology**

The Centre for Advanced Studies AKTU Lucknow (CAS) is an in-campus research driven institute of Dr. A.P.J. Abdul Kalam Technical University located at Lucknow. The institute will conduct SPOT counseling for admission in M.Tech programs for all the qualified candidates of GATE, UPSEE (PG-2020) and **other eligible candidates** (Non-GATE and non-UPSEE) for seat allocation on the basis of the merit and choices of preferences.

The merit would be prepared as per following:

1. First preference shall be given to candidate with valid GATE score.
2. Second preference shall be given to UPSEE (PG-20) qualified candidates.
3. A written exam shall be conducted for the candidates who are neither GATE nor UPSEE (PG-20) qualified. The syllabus of the written exam would be of graduation level in respective programs.

**SPOT round of counseling for GATE, UPSEE (PG-20), non-GATE and non-UPSEE (PG-2020) candidates**

**All seats are Unreserved.**

The SPOT round of counselling is through OFFLINE mode. The interested and eligible candidates have to report physically for the SPOT round of counseling.

### **Who are Eligible?**

1. Any candidate who is GATE, UPSEE (PG-20) qualified, and also not GATE/ UPSEE (PG-2020) qualified, however, he/she has the eligibility for the M.Tech programs of CAS as mentioned on <http://cas.res.in/apply-to-M.Tech.html>

**NOTE:** The candidates who have been allotted seats in previous rounds of counselling but they did not take admission, may also come for SPOT round of counselling as a fresh candidate.

- On the basis of marks scored by the candidate in the written exam, a general merit would be prepared. Allotment of only one seat would be done as per merit, availability and choices filled by the candidate.

**NOTE:** Priority regarding seat allotment shall be given for GATE and UPSEE (PG-2020) qualified interested candidates (If they will turn up for admission on the day of spot counselling). The GATE/ UPSEE (PG-2020) candidates shall be exempted from the written exam.

### **Who are NOT Eligible?**

Any candidates who have confirmed their admission by submitting seat confirmation fee (Rs. 37500/-) and has not withdrawal their admission till 26<sup>th</sup> November 2020.

**Note:** There shall be a counseling fee for the SPOT round of counseling as per following details:

**The applicants MUST carry a Demand draft (DD) of counselling Fee in favor of “Finance Officer AKTU Lucknow” payable at Lucknow.** The applications without counselling fee shall not be considered for seat allotment.

**The interested and eligible candidates MUST carry two separate DDs (One for counselling fee (either Rs. 500 or Rs. 1300 as per above details) and other for Seat confirmation fee (Rs. 37500))**

- The candidates MUST bring the original documents along with one set of photocopy of all the valid documents as per the following check list
  - (i) B.E./ B.Tech or qualifying examination final semester/Year marksheet

as per the eligibility requirements specified in the information provided on CAS website at <http://cas.res.in/apply-to-M.Tech.html>

- (ii) 10+2 passing certificate and marksheet
  - (iii) 10<sup>th</sup> certificate for date of birth
  - (iv) UP domicile certificate (For candidates who have passed their qualifying exam other than U.P.)
  - (v) Valid GATE card (if applicable)
  - (vi) UPSEE (PG-20) admit card
  - (vii) UPSEE (PG-20) rank card
  - (viii) Valid EWS certificate for EWS category seats
  - (ix) Government issued ID Card like PAN, Aadhaar etc.
  - (x) Two passport size photographs
- Online portal for inviting applications from the eligible candidates for vacant seats would be opened.
  - Choice filling for all eligible programs (Maximum up to FOUR choices as per his/her eligibility). For eligibility please check <http://cas.res.in/apply-to-M.Tech.html>
  - Required Documents to be uploaded on online portal for online form submission
  - Allotment of only one seat would be done as per merit, availability and choices filled by the candidate.
  - The successful candidates are required to deposit minimum Rs. 37500.00 as per details mentioned under heading *Seat confirmation fee* on the day of SPOT round of counselling. **The applicants are required to carry a Demand draft (DD) of Rs. 37500.00 in favor of “Finance Officer AKTU Lucknow” payable at Lucknow.** In case of failure to confirm the seat, the seat allotment will automatically be cancelled and allotted seat would be considered as vacant seat and shall be allotted to the next candidate in the merit.

### **Seat confirmation Fees:**

The candidate has to deposit **Rs. 37500/- on the day of SPOT round of counselling through Demand Draft in Favor of “Finance Officer AKTU Lucknow” payable at Lucknow**

### **Reporting, Document Verification**

The document verification shall start at 10:30 AM before the seat allotment on the day of SPOT round of counseling. The written exam for non-GATE and non-UPSEE (PG-20) shall be conducted at 11:00 AM. The candidates MUST report the counselling center at 10:30 AM.

The candidates are required to keep visiting CAS website periodically for notifications.

### **What will happen for deficiencies?**

1. If the candidate is unable to produce the required documents, he/she would not be allowed to participate in the counselling.
